   Prior intimation is required to be sent for arranging the site survey.

A complete set of bidding document in English may be purchased by interested bidders on submission of a written application on Company's Letter Head to the address below and upon payment of a non-refundable fee equivalent to Pak Rs.1000=. The method of payment will be through pay-order in the name of "Chief coordinator, Computerization & Programming (Customs), Karachi". Interested bidders who wish to receive the Bidding Documents through courier should provide an additional amount of Rs.300/- for delivery within Pakistan. A Pre-bid Meeting, with the potential bidders will be held at 1100 hours on eve of the closing date. Venue of the meeting will be at Programmers' room at 9<sup>th</sup> Floor of the Custom House, Karachi.

- 4. Bids must be delivered at the address below on or before 1100 hours of the closing date i.e 20 days from the date of publication in newspapers. All bids must be accompanied by an earnest money amounting to 2% of the bid amount in the shape of pay-order In the name of Chief Coordinator, Computerization & Programming (Customs), which shall remain valid for a period of 120 days after Bids opening. Late bids will be rejected. Bids will be opened in the presence of the bidders / representatives who choose to attend at the address below at 1400 hours, on the closing date.
- 5. Price quoted shall be paid Delivered Duty Paid (DDP) including all applicable Taxes/duties.
- Bids shall be valid for period of 03 months after opening.
- 7. All Government Taxes shall be deducted as per law. Proof of registration with Income Tax Department and Sales Tax Department should be enclosed with the Bid.
- 8. Bidders are requested to give their best and final prices as no negotiations will he held.
