Regional Tax Office, Sukkur invites sealed bids from eligible firms or persons licensed by the Pakistan Engineering Council registered in Income Tax & GST for the repair and renovation of its office / residential buildings i.e.:


- 1. Minor construction and repair of roofs and walls.
- Repair of electric works & plumbing works.
- Colour & white wash of existing walls.

NOTE:

Details of items for each category can be obtained from the office with the other documents.

TERMS & CONDITIONS:

- The terms & conditions and other specifications of each items will be available on the "TENDER NOTICE" which may be obtained from the office of the Chief Commissioner, Regional Tax Office, Queen's Road, Sukkur during office hours.
- 2. The bidder shall furnish earnest money in the shape of a Pay Order, equivalent to 3% of the estimated value of their bids, in favour of Chief Commissioner, RTO, Sukkur.
- 3. The tender documents will be available from the date of publication of this tender on PPRA Website during office hours on payment of Rs.1000/- per tender (non-refundable).
- 4. The bids should reach this office within fifteen (15) days of the publication of this notice on PPRA Website after which no bids will be entertained.
- 5. All the bids received within the prescribed time limit will be opened by authorized officers of the RTO in the presence of bidder's representatives who chose to attend at 4:30 p.m. on the closing date, in the Committee Room of Regional Tax Office, Queen's Road, Sukkur.
- 6. Any type of correcting fluid or over-writing will not be acceptable on the Tender Form.
- 7. All Governments taxes will be deducted as per laws / rules.
- 8. The bidder should enclose a copy of each of NTN Certificates, Sales Tax Registration No. & CNIC.
- 9. Incomplete tender will not be accepted in any case.
- 10. Samples can be visited during working hours other than Saturday and Sunday at RTO / Colony sites.
- 11. Payments will be made on satisfactory completion of work verified by the Committee.
- 12. The Bids and Evaluation Committee reserves the right to prior inspection of the successful bidder for the quality and quantity verification, when start the construction works.



- 13. The Contractor will complete the works at the specified locations within the mentioned days in agreement after the signing of contract.
- 14. The Bids and Evaluation Committee reserves the right to alter the quantities of items and specifications, if required and provision of any additional item not mentioned in the tendered items from the successful vender will be done after the mutual agreement.
- 15. An agreement will be signed with the successful bidders for timely completion of the project according to designing and specification.
- 16. Tender publication does not constitute any commitment on part of RTO, Sukkur.
- 17. The priority will be given to local contractors, who have already worked with FBR.
- 18. The Bids & Evaluation Committee reserves all the rights to cancel / reject any or all tenders without assigning any reason, thereof.
- 19. The rates quoted shall be valid upto 30-06-2013.
