2. The following terms and conditions shall be applied :-

TERMS & CONDITIONS

1. Tenders are required to quote price for one year subscription.
2. Tenders shall guarantee for one year un-interrupted supply of the Magazines / Journal / Web Site for which tender has been accepted.
3. The supplier will deposit performance guarantee amount equal to 10% of the total value of the items prior to the first supply to the procuring agency.
4. The supplier has to deliver items within 15 days from the date of supply order by the procuring agency, failure in compliance penalty @ 2% shall be charged per month according to PPRA, 2004.
5. The tenders are required to provide sales tax and income tax registration certificates.
6. The tenders shall specify the period from the date of acceptance of tender within which the supply of magazine shall be started.
7. In case the supplier fails to supply the goods as per laid down conditions, necessary action will be taken against the supplier as deemed appropriate including forfeitures of earnest money.
8. The tender shall be granted on the basis of competitive bidding process, specified in Public Procurement Rules, 2004.
9. The bidders should be registered with Income Tax and Sales Tax Departments having their own office & phone / fax numbers (if found contrary, the tender will be rejected).
10. The bidders should not be black-listed by any authority in the past.
