TENDER NOTICE

Sub: **PURCHASE OF 30 KVA DIESEL GENERATOR**

Sealed bids are invited from firms based in Peshawar and registered with the Sales Tax and Income Tax departments for supply & installation of 25 KVA Diesel Generator as per specifications detailed in Annexure. The following terms and conditions shall apply:

1. Income Tax/Withholding Tax will be deducted in accordance with the law. Sales Tax shall also be deducted in accordance with the law.
2. DELIVERY SCHEDULE
The delivery of the equipment mentioned in Annexure "A" is required **ON TURN-KEY AND MOST URGENT BASIS**. Therefore the lowest technically compliant bidder should be in a position to deliver the generator/equipment immediately after award of the contract. The bidders should thus quote the shortest possible delivery/installation time.
3. An authorized representative of the bidder may quote prices on the aforementioned Annexure "A" duly filled in, stamped and signed.
4. Quoted prices must be inclusive of all taxes (Income Tax and Sales Tax), indicating unit/s price and total bid price.
5. Price must be quoted including all charges like handling, loading, transportation and unloading, installation, workmanship etc. of material at the final destination.
6. The quoted price shall be valid for six (6) months from the opening date of the bids. Any subsequent changes in taxes and duties as notified by the Federal Board of Revenue shall be given due consideration.
7. Bidding Form i.e. Annexure "B" must also be duly filled in, stamped and signed by the authorized representative of the bidder.
8. EARNEST MONEY:
 - 8.1 The Bidder shall furnish as part of his bid, a Call Deposit/Pay Order equivalent to 2% of the total bid value as Earnest Money crossed in favour of "Director Intelligence & Investigation (Customs)-FBR, Peshawar.". Bank Guarantee as earnest money shall not be entertained. Any bid not accompanied by Earnest Money shall be rejected without any right of appeal.

8.2 Payment of earnest money in parts or crossed Cheque/bank guarantee, as earnest money is not acceptable.

8.3 In case of cancellation of contract on default by the Contractor the earnest money shall be forfeited in favour of "Directorate of Intelligence and Investigation (Customs)-FBR, Peshawar."

9. PAYMENT:

Payment will be made to the successful bidder in the shape of crossed Cheque after complete supply of bid item/s.

10. SEALING AND MARKING OF BIDS.

10.1 The bids shall be submitted in sealed envelope marked as under:

10.2 The envelopes shall also bear the word "CONFIDENTIAL" and the following identifications:-

10.3 If the envelope is not marked, as instructed above, the Directorate of Intelligence & Investigation (Customs)-FBR, Peshawar will not assume any responsibility whatsoever for the misplacement or premature opening of the bid.

11. DEADLINE FOR SUBMISSION OF BIDS:

All bids must be delivered in the Office of the Additional Director, Directorate of Intelligence and Investigation (Customs)-FBR, Peshawar on or before the deadline of 1100 hours on 4.06.2014.

12. LATE PROPOSALS:

Any bid received by this office after the prescribed deadline shall be returned unopened to the Bidder.

13. OPENING OF BIDS:

The Purchaser shall open the bids in the presence of the bidder's authorized representatives who choose to be present at 1130 hours on 4.06.2014 at the above mentioned address.

14. WARRANTY

14.1 The Supplier shall warrant that the equipment supplied against the Purchase Order (s) shall have no defect arising from design, materials or workmanship or from any act or omission of the Supplier that may develop under normal use of the supplied item under the conditions prevailing at final destination.

- 14.2 Period of Warranty and maintenance with labour and material cost shall be minimum "one (01) year comprehensive.

*During warranty period the supplier will be responsible to repair/replace the faulty equipment at the **installation** place free of cost within 24 hours after occurrence of a fault.*

15. All bids should include:
- 15.1 Company's profile, list of clients with their telephone numbers and addresses;
 - 15.2 Copies of Income Tax and Sales Tax registration certificates;
 - 15.3 A call deposit being 2% of the total bid value as Earnest Money crossed in favor of "Director Intelligence & Investigation (Customs)-FBR, Peshawar"
 - 15.4 Brochures and other technical material of the quoted equipment.
16. This procuring agency reserves the right to accept or reject any bid and to annul the bidding process and reject all bids at any time prior to award of Contract/(s) without incurring any liability to the effected Bidder or Bidders or any obligation to inform the effected Bidder or of the grounds for such office action.
