

Other terms and conditions:

- (i). The bids are to be submitted to the undersigned in sealed / confidential cover at the address mentioned above latest by 11am on 30-3-2015. The same shall be opened at 11:30 am on the same day by a Purchase Committee in the presence of bidders or their authorized representatives who wish to be present.
- (ii). The submitted BID (Tender) shall comprise of a single package containing two envelopes, with each envelope being marked and containing a "FINANCIAL" and "TECHNICAL" proposal. After the public opening and evaluation of the received Technical Proposals, the Financial proposals pertaining to the qualified Technical proposals shall also be opened publically at the same date, time and venue mentioned above.

- (iii). The bidders should submit separate BID (Tender) for each item i.e Computer System, Printer and Scanner. The BID (Tender) shall be evaluated accordingly.
- (iv). The quoted rates must be inclusive of all applicable duties / taxes.
- (v). Earnest money / bid security deposit @ five percent of the bid price (refundable) in the shape of call deposit in favour of Director, Intelligence & Investigation (Customs)-FBR, Peshawar should be enclosed with the bid. Any bid which is not accompanied by this earnest money / bid security at the time of opening of bid shall be outright rejected.
- (vi). The quantity of items to be purchased can be increased or decreased at the time of supply of orders.
- (vii). The validity period of the bid / rates will be applicable upto 30.6.2015 from the date of opening thereof.
- (viii). All items will have to be supplied strictly as per the minimum specifications given above and within 20 days of the issuance of the purchase order.
- (ix). Attested copies of Sales Tax Registration and NTN must be attached with the bid.
- (x). Catalogue/photos of the items must accompany the bids or should be produce at the time of opening of the sealed bids.
- (xi). The Procuring agency may reject all bids or proposals at any time prior to the acceptance of the bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for rejection of any/all bids or proposals, but is not required to justify those grounds.
- (xii). The Purchaser/Client may reject the Goods, the Services or the Works if they fail to conform to the Technical Specifications, in any test(s) or inspection(s) and the Contractor shall either replace the rejected Goods, Services or Works or make all alterations necessary to meet the Technical Specifications, within three working days, free of cost to the Purchaser/Client.
- (xiii). Payment will be made to the successful bidder in the shape of crossed Cheque after complete supply of all the bid items.
- (xiv). No bid shall be entertained after the given cut off date and time.
