Sealed bids are invited by Collectorate of Customs (Adjudication-II), Custom House, Karachi, from reputable manufacturers, suppliers & importers for the purchase of below listed items:

- 2. The tender document(s) can be obtained from Administration Branch, Collectorate of Customs (Adjudication-II), Customs House, Karachi, on cash payment of **Rs.1,000/- (non-refundable)** during office hours on or before **24.03.2015**.
- 3. Bidders are required to furnish security deposit of 5% of their offer in the shape of pay order or demand draft from scheduled Bank in favor of Collectorate of Customs (Adjudication-II), Custom House, Karachi. This security deposit shall be refunded to the unsuccessful participant of the tender. The security deposit of the successful bidder will be retained until the purchase order completed. The bidders should not be black-listed by any authority in the past.
- 4. Sealed tender bids on prescribed tender documents must be delivered to the address given below latest by 24.03.2015, before 03:00pm. The same shall be opened at 4:00pm on the same day in the presence of bidders of the tender or their authorized representatives who desire to attend.
- 5. The tender bid must be valid for at least 90 days, after opening of tenders. Government duties and taxes including stamp duty @ 0.25% of total contract amount should separately be mentioned in the Technical Proposal.

Terms and Conditions

- The purchasing contract shall be granted on the basis of competitive bidding process, specified in Public Procurement Rules, 2004.
- ii. The bidders should be registered with Income Tax and Sales Tax Departments, having their own office & phone / fax numbers (if found contrary the bid will be rejected).

- iii. The bidders should not be black-listed by any authority in the past.
- iv. Bidders are required to furnish Security Deposit 5% of their offer, in the shape of pay order or demand draft from a scheduled bank in favor of the Collector, Collectorate of Customs (Adjudication-II), Custom House, Karachi. This Security Deposit shall be refunded to the unsuccessful tender participants. The Security Deposit shall be returned to the successful bidder on completion of the tender contract and warranty period.
- v. The price shall be offered in local currency and include all duties and taxes and the expenses incurred on supplies including transportation, installation, labour etc, where required.
- vi. The tender bid must mention the type of warranty and after sale services, if any.
- vii. Sealed tender bids on prescribed tender document must be delivered to the address given below on 24.03.2015, before 03:00pm and the same shall be opened at 04:00pm on the same day in the presence of the participants of the tender or their authorized representatives who desire to attend.
 - The Collector, Collectorate of Customs (Adjudication-II), Custom House, Karachi may reject or accept any offer.
- viii. Bidders shall quote their final prices both in figures and in words, any cutting / overwriting and correction in the tender form will not be accepted.
- ix. The tender bid must be valid for at least 90 days, after opening of tenders.
- x. The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.
- xi. Procuring agencies shall announce the results of bid evaluation in the form of a report giving justification for acceptance or rejection of bids at least ten days prior to the award of procurement contract. A copy of the result shall be placed on the notice board of Collectorate of Customs (Adjudication-II), Custom House, Karachi.
- xii. Each bid shall comprise one single envelope containing, separately, financial proposal and technical proposal (if any). All bids are received shall be opened and evaluated in the manner prescribed in the bidding document.
