Sealed tenders on market rate basis (Non schedule items) are hereby invited on **06-06-2015** from firm/manufacturer duly registered with Sale Tax Department under relevant category/financial limit, who have renewed of their firms/manufacturer for the financial year i.e. 2014-2015 for the under mentioned work which will be opened on the same date at 02:00 p.m. in the presence of firms/manufacturer or their authorized representatives who care to attend. The tenders can be purchased from the office of the undersigned, on payment of requisite tender cost (not refundable) as mentioned below from the date of advertisement upto **05-06-2015** during office hours.

No tender will be sold/received by post/telegraphically or on the date of opening of tenders. Each tender must be accompanied with a Deposit at call of below mentioned amount from any scheduled Bank of Pakistan in the favour of Collector of Customs Model Customs Collectorate, Custom House, Multan without which the tender will not be entertained. The tenders will be sold only on production of original deposit at call of the requisite amount.

Model Customs Collectorate, Custom House, Multan duly issued by any schedule bank of Pakistan.

2. No tender shall be sold on the date of opening of tenders and no tender shall be sold by post /telegraphically. Moreover, conditional tender shall not be entertained at all.
3. Tenders will be opened on scheduled date and time in the office of the undersigned in the presence of those who care to attend.
4. The application must be accompanied with a call deposit of the requisite amount.
5. Tender documents shall be sold to the proprietor of the firms/manufacturer or his authorized representative or attorney holder only.
6. The documents of the firm i.e. Enlistment/renewal receipt CNIC, NTN etc. should be available with the intending firms/manufacturer at the time of purchase of tenders failing which tender will not be issued.
7. The specifications of work (Furniture) may be seen in the office of the undersigned on any working day during office hours.
8. The firms/manufacturer shall remain responsible for his bid as per PPRA rules.
9. If the firms/manufacturer disfigure/disrupt the tenders, his earnest, money will be forfeited in favour of the Government besides punitive action as per rules.
10. The firms/manufacturer who quote lesser rate than the estimated cost will have to accompany additional call deposit of the amount less than the estimated cost.
