Road, Multan (061-920377). The bidder should also provide an undertaking on

(Rs.100/- Stamp Paper) that they are not black listed by the Govt/Autonomous body otherwise they will not be eligible to bid. Further, bidders are requested to give their best & final prices as no negotiations are expected. Conditional, optional, incomplete bid and Tender without or less Pay Order amount and not fulfilling the requirements shall be considered as Non-Responsive.
