Received bids will be opened on the same day at 2.00 P.M in the office of Chairperson, tender committee.

Sealed bids should include the cost of above work (both inclusive and exclusive of all taxes), Sales Tax and Income Tax Certificates, accompanied with Pay Order (Refundable) equal to 2% of the total bid amount as earnest money in favor of Director, Directorate of Reforms and Automation (Customs), Karachi. Mr. Asfar Abbas, Manager Network (PRAL), 9<sup>th</sup> Floor, Data Centre, Custom House, Karachi will assist to provide technical information, during office timing (from 09.00 AM to 04.00 P.M), as and when required prior to appointment.

## Terms and Conditions:

- i. Earnest Money 2% of the total bid amount accompanied with Pay Order (Refundable) in favor of Director, Directorate of Reforms and Automation (Customs), Karachi.
- ii. The authority reserves the right to cancel the bid or part thereof in the light of relevant rules.
- iii. Bidder should be providing similar solution and services for at least a period of five years. The provided client details should list verifiable contact person name and telephone numbers / email addresses to whom, these services are being provided.
- iv. Bidders should have all the required licenses from PTA or equivalent to provide relevant services including fiber optics, wireless licensed frequencies and any other required licenses.
- v. It should be noted that there is a penalty associated with non compliance with maintenance schedule, 5% of total charges which will be incurred if the project is delivered late by 2 weeks, 10 % if the project is delivered late by 4 weeks, any further delay would mean discontinuation of contract.
- vi. Bidder must be Sales Tax and Income Tax registered person.
- vii. The price(s) should be valid for 90 days.
- viii. Payments will be made on the basis of inspection / testing by Technical Team and a subsequent report submission.
- ix. Government duties and taxes including stamp duty @0.25% of total contract amount should separately be mentioned in the Financial Proposal as the same is required to be paid by the successful bidder.
