- Interested bidders are requested to submit their bids on or before 1100 hours on 29-04-2016. The tender will be opened on the same day of closing date of bid at 1400 hours in the office of undersigned. Bids will be opened in the presence of bidder's representatives who choose to attend same.
- Bids received late will be rejected.
- All bids shall be valid for 30th June, 2016 w.e.f. opening date of the bid.
- All Government taxes shall be applicable as per law. Proof of registration with Income Tax & Sales Tax authorities should be enclosed with the bid.
