- The bids will be opened on the same day at 11.30 a.m. in presence of bidders who like to witness
 the opening of the Tenders.
- 4. All taxes levied by government will be deducted at source as per rules before final payments.
- The supply of all items shall be required according to the supply order, within 07 days of the approval of bid.
- The above mentioned quantity may vary upto 10% as per requirement of this Office.
- The price should be valid for next 30 days.
- The department reserves; the right to cancel the bid or part thereof for any reason however the bidder may ascertain reasons for non acceptance of his bid in writing.
- Payments shall be made on satisfactory delivery of items. The partial delivery and partial payment is allowed.
