- 2. The bidders should be registered with Sales Tax / Income Tax Department. Copy of NTN / STRN should be enclosed with the quotation.
- Prices / Rates quoted shall be inclusive of all applicable taxes / duties.
- 4. Security Deposit/Ernest money of Rs.25000/- in the form of Bank Draft/CDR each in the case of items described at Sr. No.1, 2, 3 will have to be provided along with the bid in favour of DDO, RTO, Rawalpindi.
- 5. The Purchase Committee, RTO, Rawalpindi may reject all bids or proposals any time prior to the acceptance of a bid or proposal. The Purchase Committee shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds. (Rule 33 of PPRA Rules 2004).
- 6. The Purchase Committee shall announce the results / bids evaluation in the form of a report at least fifteen days prior to the award of procurement contract.
- 7. The Contract / Tender rates shall be valid for Financial Year 2016-17.
- 8. Sealed tenders complete in all respect should reach office of the undersigned by 15.8.2016. upto 10.30 a.m. Tenders will be opened on the same date/day at 11.00 a.m. in the Conference Hall, RTO, Rawalpindi in the presence of available tenderers.
