The document will be sent by Courier Service against payment of PKR 1,000 for delivery within Pakistan and PKR 10,000 or equivalent in case of delivery abroad.
- 6. Bids must be delivered to the address below from 30 days of publication i.e. 22nd January, 2018 on or before 1100. Electronic Bidding will not be permitted. Late Bids will be rejected. Bids will be publicly opened in the presence of the Bidders' designated representatives and

anyone who chooses to attend at the address below on the last date of submission of bids i.e 22nd January, 2018.
