6. Earnest money amounting to 5% of the bid amount should be accompanied with the bid in the form of Pay order in favour of **DDO**, **DR&S**, **FBR**, **Islamabad**.

7. All bids shall be valid till 30th June, 2018 w.e.f. the date of opening of the bid.

8. All Government taxes shall be applicable as per law. Proof of registration with Income Tax & Sales Tax authorities should be enclosed with the bid.
