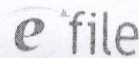
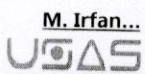
Sealed Tenders are invited for Various Heads to meet the requirement for the current financial year 2017-18 for Regional Tax Office, Sukkur from reputed firms which are registered with Income Tax / Sales Tax departments for immediate supply and services of the following items as under: -

Terms & conditions: -

- 1- The terms & conditions and other specifications of each items will be available on the "Tender Notice" which may be obtained from the office of the DDO, RTO, Sukkur during office hours.
- 2- The bidder shall furnish earnest money in the shape of a Pay Order, equivalent to 5% of the estimated value of their bids, in favour of Chief Commissioner IR, RTO Sukkur.
- 3- The tender documents will be available from the date of publication of this tender on PPRA & FBR Websites during office hours on payment of Rs. 2,000/- per tender (non-refundable).
- 4- The bids should reach this office within fifteen (15) days of the publication of this notice on PPRA & FBR websites after which no bids will be entertained.
- 5- All the bids received within the prescribed time limit will be opened by Tender Committee RTO Sukkur in the presence of bidder's who are required to attend at 04:30PM on the closing date, in the Committee Room of Regional Tax Office, Queen's Road, Sukkur. Each bid is to be accompanied with a sample of the item in the form which the bidder will supply. (all samples will be reserved upto award of supply/contract to the successful bidder by tender committee).
- 6- Any type of correcting fluid or over-writing will not be acceptable on the Tender Form and only typed quotations will be considered.
- 7- All Governments taxes will be deducted as per laws / rules.
- 8- The bidder should enclose a copy of each of NTN Certificates, Sales Tax Registration No. & CNIC of the proprietor & profile of company with Engineering Council Registration certificate for Building works bidders.
- 9- Incomplete tender will not be accepted in any case.
- 10- The Purchase Committee/Tender committee, RTO, Sukkur reserves the right to cancel any or all bids either in whole or in part as per rules.
- 11- Successful bidders have to supply items as per work order with in 15 working days.
- 12- The bids shall remain valid for the work orders to be issued upto 30/06/2018.
- 13- The payment will be made on the supply of items and clearance of bills from District Accounts Officer, Sukkur after proper satisfactory supplies made.
