**TERMS & CONDITIONS**

- i. The firm must be registered with the Sales Tax and Income Tax departments (i.e., it should have its own GST #/ NTN # and AGPR's issued Vendor No).
- ii. The Firm/ Supplier/ Contractor must be locally based (i.e., in Islamabad/ Rawalpindi) with its own independent Office/ Shop having facility of phone/ fax/ email.
- iii. The firm / supplier / contractor shall be responsible for the delivery of purchased items at New Islamabad International Airport.
- iv. The bids must be accompanied by security deposit @5% of the value of the contract (refundable as per rules) in the shape of Pay Order/ Demand Draft in favor of DDO, Model Customs Collectorate, Islamabad (Cheque is not acceptable).
- v. Quantity can be increased / decreased in the light of available budget
- vi. A declaration on stamp paper regarding non-black listing of the Firm/ Supplier/ Contractor must be provided with the bid documents.
- vii. The Chairman Purchase Committee shall reserve the right to reject/ amend all/ any bid(s) as per the provisions contained in Public Procurement Rules.
- viii. In case of any dispute / grievance, the Collector Model Customs Collectorate, Islamabad shall be arbitrator as envisaged in Rule 49 of Public Procurement Rules, 2004.
