Sealed bids are invited from financially sound and reputable firms registered with Sales Tax and Income Tax Departments and Sindh Revenue Board (if required) for providing services of the following crew members preferably retired Pakistan Navy Personnel, having requisite experience and qualification. The contracting firm/organization should have requisite experience and repute in supplying the following crew members who are capable of handling two FRP boats fitted with waterjet propulsion system, during high sea operations and at mooring. The contracting firm should also be capable of carrying out the first line maintenance of both the boats as per manufacturer's manual.

- 2. Sealed bids must be dropped in the Tender Box placed in the Administration Branch, MCC Preventive, 6th Floor, Custom House, Karachi by 18th June, 2018 upto 1400 hours. These bids will be opened on same day at 1500 hours in the presence of bidders or their authorized representatives who may like to witness the opening up of sealed tenders.
- 3. Following documents must be attached with the tender documents;

- iii. Copy of SRB Registration Certificate.
- iv. Business profile for the last 3 years.
- v. Authority letter showing the details of authorized person.
