- 6. Earnest money amount to 5% of the bid amount should be accompanied with the bid in the **form of Pay Order in favor of DDO, DR&S, FBR, Islamabad**.
- 7. All bids shall be valid till 30th June, 2019 w.e.f. opening date of the bid.
- 8. All Government taxes shall be applicable as per law. Proof of registration with Income Tax & Sales Tax authorities should be enclosed with the bid.
- 9. The **Directorate of Research & Statistics, Islamabad** reserves the right to cancel the tender and/or to add/reduce the quantity of above items as per **PPRA Rules**, **2004**.
