Sealed bids are invited by Model Customs Collectorate of Appraisement (East), Customs House, Karachi, from reputable service providers having sound profile and experience for complete Operations & Maintenance (O&M) Annual Maintenance (AMC) of Diesel Gen-Set, as per tender document(s). The tender document(s) can be obtained from Administration Branch, Model Customs Collectorate of Appraisement (East), Customs House, Karachi, on cash payment of <u>Rs.1,000/- (non-refundable)</u> during office hours on or before <u>10.05.2019</u>.

Terms and Conditions

- i. The maintenance and services contract shall be granted on the basis of competitive bidding process, specified in Public Procurement Rules, 2004.
- ii. The bidders should be registered with Income Tax and Sales Tax, Sindh Sales Tax Departments, having their own office & phone / fax numbers (if found contrary the bid will be rejected).
- iii. The bidders should not have been black-listed by any authority in the past.
- iv. Bidders are required to furnish Security Deposit of 5% of their offer, in the shape of pay order or demand draft from a scheduled bank in favor of the Collector, Model Customs Collectorate of Appraisement (East), Customs House, Karachi. This Security Deposit shall be refunded to the unsuccessful tender participants. The Security Deposit shall be returned to the successful bidder on completion of the period of tender contract.
- v. The price shall be offered in local currency and include all duties and taxes and the expenses incurred on supplies including transportation, installation, labour etc, where required.
- vi. The tender bid must mention the type of warrantee and after sale services, if any.
- vii. Sealed tender bids on prescribed tender document must be delivered to the address given below on 10.05.2019, before 03:00pm and the same shall be opened at

03:30pm on the same day in the presence of the participants of the tender or their authorized representatives who desire to attend.

- viii. The bidders shall quote their final prices both in figures and in words, any cutting / overwriting and correction in the tender form will not be accepted.
- ix. Bidders are required to give complete description, catalogue of equipments along with their offer.
- The tender bid must be valid for at least 90 days, after opening of tenders. The X. price offered should be inclusive of Government duties and taxes including Sales Tax, Sindh Sales Tax stamp duty @ 0.25% of total contract amount should separately be mentioned in the Financial Proposal.
- The procuring agency may reject all bids or proposals at any time prior to the xi. acceptance of a lid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.
- xii. Procuring agency stall announce the results of bid evaluation in the form of a report giving justification for acceptance or rejection of bids at least ten days prior to the award of progurement contract. A copy of the result shall be placed on the notice board of Model Customs Collectorate of Appraisement (East), Custom House, Karachi,
- xiii. Each bid shall covarise one single envelope containing, separately, financial proposal and teeli cal proposal (if any). All bids received shall be opened and evaluated in the number prescribed in the bidding document.
- Payments will be under on the basis of verification / inspection /testing by xiv. Technical Term and subsequent report submission.
