## Terms & Conditions:

- 1. The terms & conditions and other specifications of each item will be available on the "TENDER DOCUMENTS" which may be obtained from the office of the D.D.O, Regional Tax Office –III (Inland Revenue) Karachi, after payment of Rs. 1,000/- non refundable during office hours.
- 2. The bidder shall furnish earnest money in the shape of a Pay Order, equivalent to 5% of the estimated value of their total bid value (Gross Total), in favor of Chief Commissioner Inland Revenue Regional Tax Office –III Karachi.
- 3. The Tender document will be available from **09-05-2019 to 24-05-2019.**The bids should reach this office on or before **24-05-2019**, **at 11:00 A.M.**
- 4. All the bids received within the prescribed time limit will be opened by authorized officers of the Regional Tax Office –III (Inland Revenue) Karachi in the presence of Bidder's representatives who choose to attend at 11:30 A.M on 24-05-2019, in the Committee Room situated at 2<sup>nd</sup> Floor of Inland Revenue House, Regional Tax Office –III (Inland Revenue), Plot No. FL.16/17, Block-15, Gulistan-e-Jauhar, Karachi. Each bid is to be accompanied with a sample of the item in the form which the bidder will supply, (all samples will be reserved upto award of supply contract to the successful bidder)



- 5. Any type of correcting fluid or over writing will not be acceptable on the Tender form and only typed quotations will be considered.
- 6. All government taxes will be deducted as per laws/rules.
- 7. The bidder should enclose a copy each of NTN Certificates, Sales Tax Registration Certificate and CNIC of the proprietor.
- 8. Incomplete tender will not be accepted in any case.
- 9. The Procurement Committee, Regional Tax Office –III (Inland Revenue) Karachi reserves the right to cancel any or all bids either in whole or in part **as per rule.**
- 10. Successful bidders have to supply items as per work order with 05 working days.
- 11. The bids shall remain valid for the work orders to be issued up to **30-06-2019**.
- 12. The payment will be made on the supply of items and clearance of bills from DGPR, Karachi.
