Sealed bids are invited from firms/entities registered with Government having proper shops/stores and telephone/fax facilities at Islamabad/ Rawalpindi for supply of consumable stationery items, Toners, Cartridges, Paper Reams, Electrical and other miscellaneous items etc.. & for repair services for financial year 2019-20. Bidders should be registered with Income Tax and Sales Tax Departments, and must be on Active Tax Payer's List of FBR.

- 2. Interested Bidders may obtain the list of required items and detail Bidding Documents containing all the required details from the office of the undersigned in person or through their Authorized Representatives on any working day on written request and CNIC during office hours by submitting Pay Order of PKRs.1000/-(Non-Refundable) on name of DDO FBR (Hqrs). Bidding Document shall not be issued to any unauthorized person. Bidding shall be carried out by following Single Stage One Envelope Procedure.
- 3. Security deposit in the form of Bank Draft/CDR shall have to be deposited in favour of DDO, FBR, as per details given:-

i)	Toner/papers and other Consumable items	Rs.200,000/-
ii)	Consumable items other than Toner/papers	Rs.100,000/-
iii)	Electric/misc items	Rs.50,000/-
iv)	Repair of Photo copiers/Copy Printers & their annual services	Rs.100,000/-

vi)	Repair of AC split Units	Rs.30,000/-
vii)	Repair of furniture	Rs.30,000/-

- 4. Bids shall be valid for 120-days. In case of unsuccessful tenders, Call Deposit will be released/returned within a fortnight after award of contract and in case of successful bidders the same shall be released on furnishing of performance security.
- 5. Bidders shall quote rates both exclusive and inclusive of taxes in the Bidding Document for comparison and shall remain valid upto 30.06.2020, but contract is liable to be extended for a period of another three months and no request for increase in prices shall be considered on any ground, during the original or extended period of the contract. All Government Taxes shall be deducted as per Law. Any levies imposed later-on by the Government during the year would not entitle contractor for any escalation in rates.
- 6. In case of Toners/Cartridges, Bidder should be an Authorized Distributer/Agent of the Original manufacturer and is bound to provide original manufacturer's Warranty and Specifications for Toners, Cartridges and Electrical Items. In case of imported items, import documents are required to be produced in respect of the items supplied. Rates must be quoted for the original/genuine brands.

- 7. Blacklisted firms and Bidders cannot participate in Bidding process. An Affidavit that Bidder has never been Black Listed by any Ministry/Division/Department /Government Organization should accompany the Bid.
- 8. Successful Bidder is bound to supply sample of each item to the Bid Evaluation Committee, which will be matched with the supplied items at belated stage for confirmation and similarity. Contractor shall be bound to supply/deliver the goods by using their own means of transport even on a short notice at store of FBR(HQ) situated in the basement/roof of FBR building.
- 9. Competent authority will have the right to terminate the contract during the currency of the year, if items are found sub-standard or not genuine/branded, short in quantity and not supplied timely, appropriate action against the contractor shall be taken as per Public Procurement Rules, 2004.
- 10. A Pre-Bid meeting shall be held on 10th October, 2019 in the Conference Room of FBR Hqrs to address any query of the prospective Bidders.
- 11. Sealed Bids prepared in accordance with instructions contained in the Bidding Documents, complete in all respect should reach in the office of the undersigned Room No.530, 5^a floor, FBR(HQ) on 16th October 2019 at 11.00 a.m. Tenders will be opened on the same date at 11.30 a.m. in the Conference Room of FBR(HQ) in the presence of available bidders or their authorized Representatives.
- 12. Procuring agency reserves the rights to reject any or all bids in terms of Rule 33 of PPRA Rules 2004.
