2. The tender document(s) can be obtained from Administration Branch, Model Customs Collectorate Appraisement & Facilitation (East), Customs House, Karachi, on cash payment of **Rs.1,000/- (non-refundable)** during office hours on or before **21.122020.**

Terms and Conditions

- i. The maintenance and services contract shall be granted on the basis of competitive bidding process, specified in Public Procurement Rules, 2004.
- ii. The bidders should be registered with Income Tax, Sales Tax and Sindh Sales Tax Departments, having their own office & phone / fax numbers (if found contrary the bid will be rejected).
- iii. The bidders should not have been black-listed by any authority in the past.
- iv. Bidders are required to furnish Security Deposit of 5% of their annual offer, in the shape of pay order or demand draft from a scheduled bank in favor of the **Collector, Model Customs Collectorate Appraisement & Facilitation (East), Customs House, Karachi.** This Security Deposit shall be refunded to the unsuccessful tender participants. The Security Deposit shall be returned to the successful bidder on completion of the tender contract.
- v. The price shall be offered in local currency and include all duties and taxes and the expenses incurred on supplies including transportation, installation, labour etc,

- vi. The tender bid must mention the type of warranty and after sale services, if any.
- vii. Sealed tender bids on prescribed tender document must be delivered to the address given below on **21.12.2020**, before **02:00pm** and the same shall be opened at **2:30pm** on the same day in the presence of the participants of the tender or their authorized representatives who desire to attend.
- viii. Bidders shall quote their final prices both in figures and in words, any cutting / overwriting and correction in the tender form will not be accepted.
- ix. The tender bid must be valid for at least **90 days**, after opening of tenders. Government duties and taxes including stamp duty @ 0.25% of total contract amount should separately be mentioned in the Technical Proposal.
- x. The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who has submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.
- xi. Procuring agency shall announce the results of bid evaluation in the form of a report giving justification for acceptance or rejection of bids at least ten days prior awarding of procurement contract. A copy of the result shall be placed on the notice board of Model Customs Collectorate Appraisalment & Facilitation (East), Custom House, Karachi.
- xii. Each bid shall comprise one single envelope containing, separately, financial proposal and technical proposal (if any). All bids received shall be opened and evaluated in the manner prescribed in the bidding document.
- xiii. The offer shall be valid for and up to **18.02.2020**.
