- 3. Prices / Rates quoted shall be inclusive of all applicable taxes / duties.
- 4. Security Deposit/Earnest money of Rs.25,000/- in the form of Bank Draft/CDR will have to be provided along with the bid in favour of DDO, RTO, Rawalpindi.
- 5. The Tender Purchase Committee, RTO, Rawalpindi may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The Purchase Committee shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds. - 6. The Purchase Committee shall announce the results / bids evaluation in the form of a report at least fifteen days prior to the award of procurement contract.
- 7. The Contract / Tender rates shall be valid for Financial Year 2019-20.
