Sealed bids must be dropped in the Tender Box placed in the Administration Branch, MCC Enforcement & Compliance, 6<sup>th</sup> Floor, Custom House Karachi by 08<sup>th</sup> June 2020 upto 1400 hours. These bids will be opened on the same day at 1500 hours in the presence of bidders or their authorized representatives who may like to witness the opening up of sealed bidders.
- 3. Following documents must be attached with the tender documents:
  - i. Copy of valid Sales Tax Registration.

- ii. Copy of valid Income Tax Registration.
- iii. Business Profile of last 3 years.
- iv. Authority letter showing the details of authorized person.
- v. Copy of CNIC of the authorized person.
- vi. An affidavit confirming that the company is not black listed anywhere.
- 4. The competent authority reserves the right to accept or reject any or all bids in accordance with the provisions envisaged under Rule-33 of PPRA Rules 2004.
- 5. No bidder will be allowed to alter or modify his/ her bid after opening of the bids.
- No conditional bids will be accepted.
