

4.	Time & Place of opening of bids	05.06.2020 at 11:55am (morning) 6 <sup>TH</sup> Floor Model Customs Collectorate Enforcement & Compliance Custom House, Karachi.
5.	Opening of Bids	All bids shall be opened publicly in the presence of bidders or their representatives who may choose to be present, at the time and place announced prior to the bidding. All bids submitted after the time prescribed shall be rejected and returned without being opened.


