

Following bidders/firms are eligible to participate in the tender process;

- 1. Registered with Tax Authorities i.e. Income Tax and Sales Tax Department.
- 2. Reputable Original Manufactures or its authorized dealers.
- 3. With sound financial position duly supported by Bank Statements.
- 4. Not blacklisted by any Government / Semi Government Department.
- 5. Providing list of Managerial and Technical staff with qualifications.
- 6. Providing details of manufacturing Plant / Machinery.
- 7. The rate of every item should be separately quoted including Income Tax / Sales Tax as per law. All bidders shall provide samples of their items.
- 8. Incomplete tenders will not be considered in any case.
- 9. Willing to provide the items within 20 days of issuance of Supply Order.

The procurement will be made as per <u>Single Stage-Two Envelope System</u> provided in Public Procurement Rules, 2004.

Tender forms alongwith specifications of the above mentioned goods/items/services may be obtained from the office of the undersigned during working hours well before opening of the bids by paying Rs.1,000/- as Tender Fee in the shape of D.D/Pay order in the name of Chief Commissioner-IR, Regional Tax Office, Sargodha.

The interested / eligible firms are invited to send their sealed offers on the approved Tender Forms to the undersigned alongwith CDR amounting to 2% of the bid amount in the name of the Chief Commissioner-IR, Regional Tax Office, Sargodha as Bid Security. Closing time for submission of bids is 02:00 PM on 21.5.2020. Tenders shall be opened on the same day at 03:00 PM by the Purchase Committee, Regional Tax Office, Sargodha in the presence of all bidders or their representatives Conference room, Regional Tax Office, Sargodha.
