
PUBLIC NOTICE

It is hereby notified for general public that an open auction of only **seized / confiscated perishable goods** pertaining to the Directorate of Intelligence and Investigation-Customs, Quetta, will be held from 1st February, 2021 to 5th February, 2021 (on daily basis) at 11:00am at **Directorate of Intelligence & Investigation - Customs, Quetta.**

TERMS & CONDITIONS:

- i. Auction shall be held strictly in accordance with the provision of the Customs Act, 1969 and rules there under. All the interested parties / bidders shall abide by all the conditions ordained under the relevant provisions of the Act and Rules.
- ii. Auction will be on "AS IS, WHERE IS" basis and no request whatsoever for cancellation of Auction on the basis of any deficiency, if found in auctioned goods after fall of hammer shall be accepted.
- iii. Interested bidders have to strictly follow the SOPs in order to avoid the spread of COVID-19(Corona-virus) i.e. wearing of face mask, use of hand sanitizers, social distancing etc.
- iv. Interested bidders shall deposit Rs.25,000/= (Rupees Twenty Five Thousand only) as call deposit in favour of Additional Director, Intelligence & Investigation-Customs, Quetta.
- v. Intending bidder has to present valid original CNIC and submit copy thereof.
- vi. Successful bidder has to deposit 25% of the highest bid as earnest money on the spot. Balance amount shall be deposited within 07 days of the display of the approved lots on the Notice Board failing to which the earnest money shall, subject to rules, be forfeited in favour of the Federal Government.
- vii. Earnest money can be deposited in the form of bank pay order.
- viii. Bidder can send their highest bid through sealed bid mentioning the Lot No. alongwith copy of CNIC in the form of bank pay order that will be opened in front of all bidder at the time of auction.

- ix. The competent authority reserves the right to accept or reject any bid without assigning any reason.
- x. 10% of the approved bid as Advance Income Tax shall be deposited separately by the successful bidder in case of filler.
- xi. 20% of the approved bid as Advance Income Tax shall be deposited separately by the successful bidder in case of non-filler.
- xii. The goods put to auction can be inspected on any working day during office hours at the aforesaid address.
- xiii. Any further information, so required, may be obtained from M/s ANR Enterprises or Incharge State Warehouse, Directorate of Intelligence & Investigation – Customs, Quetta.

- ii. Auction will be on "AS IS, WHERE IS" basis and no request whatsoever for explanation of Auction on the basis of any deficiency or fault in auctioned goods, after bid of bidder shall be accepted.
- iii. Interested bidders have to strictly follow the instructions issued to attend the special of COVID-19 (Corona virus) i.e. wearing of face mask, use of hand sanitizers, social distancing etc.
- iv. Interested bidders shall deposit maximum amount (Twenty Five Thousand only) as call deposit in favour of Additional Director, Intelligence & Investigation - Customs, Quetta.
