The Tender documents along with specifications/ descriptions may be obtained from the <u>Accounts branch MCC Gwadar, at Customs House, Gaddani,</u> <u>District Lasbela</u> in the form of request on the letter head of the Firms/Suppliers at a cost of <u>Rs. 1,000/- (non-refundable)</u>, during office hours on or before <u>07.05.2021</u>.

## **Terms and Conditions**

i. The tender shall be granted on the basis of competitive bidding process, as is embodied in Public Procurement Rules, 2004.

ii. The bidder should be registered with Income Tax, Sales Tax, having their own office & Phone / fax numbers (if found contrary, the tender will be rejected).

iii. The bidders should not have been black-listed by any authority in the past.

- iv. The bidders are required to furnish security deposit of 2% of their offer, in the shape of pay order or demand draft from a scheduled bank in favor of the <u>DDO</u>, <u>Model Customs Collectorate, Gwadar</u>. The Security deposit shall be refunded to the unsuccessful bidder(s). The Security Deposit shall be returned to the successful bidder on completion of the tender contract.
- v. The price shall be offered in local currency and include all duties/ taxes and the expenses incurred on supplies including transportation, labour etc, where required.
- vi. The tender bid must mention the type of warrantee and after sale services, if any.
- vii. Sealed tender bids on prescribed tender documents must be delivered to the address given below on <u>07-05-2021</u>, before <u>10:30 am</u> and the same shall be opened at

<u>11:30 am</u> on the same day in the presence of the participants of the tender or their authorized representatives who desire to attend.

- viii. Bidder shall quote their final prices both in figures and in words, any cutting / overwriting and correction in the tender form will not be accepted.
- ix. Bidders are required to give complete description, catalogue of items along with samples of their offers.
- x. The tender bid must be valid for at least **90-days**, after opening of tenders.
- xi. Payments will be made on the basis of verification / inspection by concerned staff and subsequent report submission.
- xii. The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall, upon request, communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposal, but is not required to justify those grounds.
- xiii. The procuring agency shall announce the results of bid evaluation in the form of a report giving justification for acceptance or rejection of bids at least three days prior to the award of procurement contract. A copy the result shall be placed on the notice board of **Model Customs Collectorate Gwadar, Custom House Gaddani**.
