- 2. Tender documents and other specifications will be available during office hours.
- 3. The bids may be submitted to the undersigned in sealed / confidential cover at the address mentioned below within 15 days of the publication of this notice in the newspaper till 02:00 PM (sharp) which will then be opened at 03:00 PM (sharp) on same day by the Purchase Committee, Regional Tax Office, Sargodha in the presence of the bidders or their representatives who choose to attend the bid opening process.
- 4. All bidders shall provide samples of their items.
- 5. 3 % bid money of the total amount of quotations in the name of the Chairman Purchase Committee in the shape of Bank draft issued by any scheduled bank of Pakistan valid for 120-days should accompany the quotations.
- 6. The bidders must be registered with Sales Tax/Income Tax Department. Copy of NTN/STRN Certificates must be enclosed with the quotation. The rate of every item must be separately quoted including Income Tax / Sales Tax as per law / given format.
- 7. Incomplete quotations will not be considered in any case.
- 8. The competent authority / Purchase Committee may reject any bid or all bids under Rule-33 of the Public Procurement Rules, 2004.

The procurement will be made as per <u>Single Stage-Two Envelope System</u> provided in Public Procurement Rules, 2004.

Tender forms alongwith specifications of the above mentioned goods/items/services may be obtained from the office of the undersigned during working hours well before opening of the bids by paying Rs.1,000/- as Tender Document Fee (Non-Refundable) through bank challan 32-A Tender Account No.C03841-Fees.
