2. As per law, 10% withholding tax shall be paid by the successful bidder/offerer of the accepted bid amount of the auctioned subject POL products. Interested/eligible bidders or offerer (OMCs) as defined in Rule 49 may participate in Auction by way of submission of sealed tender/offer, in the name of Director of Customs, Intelligence & Investigation-Customs, Multan.

3. Aforementioned sealed tenders/offers must be received in this Directorate up to **1:00PM on 23.06.2021**. The tenders/offers shall be opened at 2:00PM on the same day by the competent authority in the presence of all participants. The highest tender/offer shall be considered for processing of the case and submit to the competent authority in terms of Rule 73 of Customs Rules. In case of acceptance of the offer by the competent authority under aforementioned Rules, rest of the amount shall be paid by the successful bidder within a period of seven (07) days under Rule 68 of the Customs Rules. In case of rejection of the bid earnest money shall be refunded to the bidder under Rule 74 of Customs Rules.

Other terms and conditions:

- a) Place of delivery shall be the Directorate of I&I-Customs, Regional Office, Multan respective Customs Station, where the goods are lying as mentioned vide para-1 above.
- b) Bids/offers completed in all respect shall be addressed to the Director, Directorate of Intelligence and Investigation-Customs, Regional office, House No. 4, Iteefaq Town Opposite Edhi Homes, Khanewal Road, Multan must reached in the office of the undersigned at above mentioned date and time.
- c) All the Oil Marketing Companies (OMC's) will be represented by their authorized employees/persons only, carrying original CNIC and authority letter.
- d) Only authorized person shall be entertained and allowed to be present at the time of opening of sealed tender/offer.
- e) bids/offers received after the due date and time will not be entertained.
- f) Incomplete and conditional bids will not be entertained.
- g) Bids of blacklisted bidders by any government Agency/Department will not be considered.
- h) Bidders engaged in corrupt or fraudulent practices (including collusion/pooling) will be declared ineligible either indefinitely or for stated period of time.
- i) Only eligible bidders may apply with proof (copy of license and others documents) for entitlements of purchase and/ or sale of the above said product.
- j) The quantity of goods available may increase or decrease, depending upon decisions in respective cases by the court of law or addition of further confiscated quantities.
- k) The competent authority reserves the right to accept or reject any or all bids with or without assigning the grounds/justifications for approval or rejection as provided under Rule 75 of the Customs Rules.
- l) Each participant shall give sealed quotations/bids separately for each lot/product along with 25% earnest money in the form of pay order or bank demand draft made from the company's account in favour of Collector of Customs
