Subject: - **TENDER FOR PURCHASE OF UNIFORM FOR CLASS-IV STAFF 2021 -22.**

In terms of instructions contained in PPRA Rules, the Collectorate of Customs, Islamabad hereby submits its bidding notice for publishing on PPRA website, whereby this Collectorate intends to tender for Purchase Uniform for Class-IV staff for the Financial Year 2021-22 detailed as under:-

S.No.	NAME OF UNIFORM ITEMS
A.	MALE CLASS-IV REGULAR SUMMER WEAR (IMAGE-V):
1	Trouser: (Charcoal Grey, Plain bottom without turn-up with two straight pockets on the sides and two back pockets)
2	Shirt: shirts for men during summer shall be made of plain Charcoal Grey fabric. The shirt shall have an attached pointed collar with either full or half sleeves having two breast pockets. The shirt shall have shoulder loops to house the epaulettes and ranks. The Pakistan's flag must be worn on the upper left arm. (as per Image-VI)
3	Footwear: Shoes shall be with Maximum 2" heels, Black color Oxford pattern without toe cap having five (5) eyelets for shoe laces.
4	Socks: (Black Colour)
5	Customs Insignia: It shall be of a silver colour metal badge of a design as per Image-VII) to be worn on front, left side of chest.
6	Belt: Shall be Black Colour Leather / Nylon, wider than standard Uniform belt with silver metal buckle having embossed Customs insignia of a design as per (Image-VIII)
7	Beret: shall be in black Colour, the design of insignia on the beret for officers of BS1 to 19, BS-20 and BS-21 shall be as per (Image -IX)
8	Name Plate: (Name Plate shall be of black colour, plastic material, measuring ½" x 3" rectangular shape, name of officer duly engraved in white color.
B.	MALE CLASS-IV REGULAR WINTER WEAR (IMAGE-V) :
1	Jersey: Charcoal Grey V-Neck Jersey having leather patches on elbows and Shoulders. It shall have shoulder flaps to house the ranks and silver Buttons and Pakistan's Flag on the upper left arm as per (Image VI)
2	Trouser: (Charcoal Grey, Plain bottom without turn-up with two straight pockets on the sides and two back pockets)
3	Shirt: Shirt Shall be made of Charcoal Grey Cloth, Shall have attached pointed collar and full sleeves without breast pockets and without shoulder loops.
4	Footwear: Shoes shall be with Maximum 2" heels, Black color Oxford pattern without toe cap having five (5) eyelets for shoe laces.
5	Socks: (Black Colour)
6	Customs Insignia: It shall be of a silver colour metal badge of a design as per Image-VII) to be worn on front, left side of chest.
7	Belt: Shall be Black Colour Leather / Nylon, wider than standard Uniform belt with silver metal buckle having embossed Customs insignia of a design as per (Image-VIII)
8	Beret: shall be in black Colour, the design of insignia on the beret for officers of BS1 to 19, BS-20 and BS-21 shall be as per (Image -IX)
9	Name Plate: (Name Plate shall be of black colour, plastic material, measuring ½" x 3" rectangular shape, name of officer duly engraved in white color.
C.	MALE CLASS-IV CUSTOMS FIELD UNIFORM (CFU) (IMAGE-II)
1	Shirt: Charcoal Grey camouflage shirt / Printed polo shirts with Pakistan's Flag on the upper

	left arm (as per image-VI), Shall be worn with Charcoal Grey , Six pockets cargo pants by all officers, officials and sepoy engaged in the field operations / duties. The polo shirts shall have printed stripes on the centre of the shirt, below the button according to the ranks of the officers.
2	Trouser: Charcoal Grey, camouflage, six pockets cargo pants
3	Name Tag: Name tag embroidered in silver thread shall be attached on Velcro tape on right side of the chest (as per image-X)
4	Customs Insignia: It shall be of a silver colour metal badge of a design as per Image-VII) to be worn on front, left side of chest.
5	Web Belt: Web belt shall be black color with wider silver metal buckle having embossed Customs insignia (as per image-VIII)
6	Polo Caps/ Hats: Polo caps / hats of black colour shall be worn with Customs badge. There shall be silver be silver braids on cap for BS-19 and above ; one braid on the caps of BS-19 officers and two braids on the cap of BS-20 and above (as per Image IX)
7	Winter Jacket: Charcoal Grey water-proof material jacket with full front, open zip, two side pockets and hoodie and bearing the service badge on the front left side (in silver), ranks on the collar and Pakistan Customs written on the back and Pakistan's flag on the upper left arm (as per image-VI)
8	Shoes: Balck Colour, long Double-Molded Sole (DMS) Shoes.
9	Socks: Black Socks for Double-Molded Sole (DMS) Shoes.
J.	FEMALE CLASS-IV REGULAR SUMMER WEAR (IMAGE-V):
1	Shirt: Charcoal Grey bush shirt with five (5) buttons, attached pointed collar and full sleeves. The length of the shirt shall be at most two inches below the hips. The shirt shall have shoulder loops to house the epaulettes and Pakistan's flag on the upper left arm as per Image-VI)
2	Trouser: Straight trouser shall be of Charcoal Grey colour. It shall have a plain bottom without turn-up with two straight pockets on the sides and two back pockets.
3	Head Scarf (Optional): Head Scarf Shall be wash and wear material of the same colour as of the shirt.
4	Footwear: Shoes shall be with Maximum 2" heels, Black color Oxford pattern shoes without toe cap having five (5) eyelets for shoe laces.
5	Socks: Socks shall be of black colour, up to calf length.
6	Customs Insignia: It shall be of a silver colour metal badge of a design as per Image-VII) to be worn on front, left side of chest.
7	Web belt: Web belt shall be black color with wider silver metal buckle having embossed Customs insignia (as per image-VIII)
8	Beret: shall be in black Colour, the design of insignia on the beret for officers of BS1 to 19, BS-20 and BS-21 shall be as per (Image -IX)
9	Name Plate: (Name Plate shall be of black colour, plastic material, measuring ½" x 3" rectangular shape, name of officer duly engraved in white color.
K.	FEMALE CLASS-IV REGULAR WINTER WEAR (IMAGE-V) :
1	Great Coat (Optional for Colder Climate Areas): French Charcoal Grey great coat with silver Buttons and stripes on the arms according to ranks. No stripe for BS-17, one (1) stripe for BS-18, two (2) stripes for BS-19, Three (3) stripes for BS-20 and four (4) stripes for BS-21 shall be as per (Image VI)
2	Bush Coat: Charcoal Grey bush coat of merino wool fabric with four (4) silver buttons, notched lapel collar and full sleeves. There shall be four pockets on the front and the length of the coat shall be at most two inches below the hips . The coat shall have shoulder loops to house the epaulettes and Pakistan's flag on the upper left arm as per (image-VI)
3	Shirt: A Charcoal Grey colour collarless inner shirt, less than the length of the coat.
4	Trouser: Straight trouser shall be of Charcoal Grey colour. It shall have a plain bottom4 without turn-up with two straight pockets on the sides and two back pockets.
5	Footwear: Shoes shall be with Maximum 2" heels, Black color Oxford pattern shoes without toe cap having five (5) eyelets for shoe laces.
6	Socks: Socks shall be of black colour, up to calf length.

7	Customs Insignia: It shall be of a silver colour metal badge of a design as per Image-VII) to be worn on front, left side of chest.
8	Web belt: Web belt shall be black color with wider silver metal buckle having embossed Customs insignia (as per image-VIII)
9	Beret: shall be in black Colour, the design of insignia on the beret for officers of BS1 to 19, BS-20 and BS-21 shall be as per (Image -IX)
10	Name Plate: (Name Plate shall be of black colour, plastic material, measuring ½" x 3" rectangular shape, name of officer duly engraved in white color.
L.	FEMALE CLASS-IV CUSTOMS FIELD UNIFORM (CFU) (IMAGE-II)
1	Shirt: Charcoal Grey camouflage shirt / Printed polo shirts with Pakistan's Flag on the upper left arm (as per image-VI) , Shall be worn with Charcoal Grey , Six pockets cargo pants by all officers, officials and sepoys engaged in the field operations / duties. The polo shirts shall have printed stripes on the centre of the shirt, below the button according to the ranks of the officers.
2	Trouser: Charcoal Grey, camouflage, six pockets cargo pants
3	Name Tag: Name tag embroidered in silver thread shall be attached on Velcro tape on right side of the chest (as per image-X)
4	Customs Insignia: It shall be of a silver colour metal badge of a design (as per image-VII)
5	Web Belt: Web belt shall be black color with wider silver metal buckle having embossed Customs insignia (as per image-VII)
6	Polo Caps/ Hats: Polo caps / hats of black colour shall be worn with Customs badge. There shall be silver be silver braids on cap for BS-19 and above ; one braid on the caps of BS-19 officers and two braids on the cap of BS-20 and above (as per Image IX)
7	Winter Jacket: Charcoal Grey water-proof material jacket with full front, open zip, two side pockets and hoodie and bearing the service badge on the front left side (in silver), ranks on the collar and Pakistan Customs written on the back and Pakistan's flag on the upper left arm (as per image-VI)
8	Shoes: Balck Colour , long Double-Molded Sole (DMS) Shoes.
9	Socks: Black Socks for Double-Molded Sole (DMS) Shoes.

GST/NTN registered firms may submit their bids, as per following conditions:-

- Bids should reach the undersigned by **24.09.2021** at **1230 hours** or 25 days after the publishing of this advertisement on PPRA website, whichever is later.
 - Bids should be attached with pay order in the name of "DDO Collectorate of Customs, Islamabad" equivalent to Rs. 50,000/- as call deposit.
 - Bids shall be opened at **14.00 hours** the same day (**24.09.2021**) in the presence of competitors.
 - Successful bidder will have to provide the uniform during the financial year 2021-22 within 25 days after the issuance of purchase orders failing which the amount of call deposit shall be forfeited and order shall stand cancelled.
 - The samples of uniform of officials may be obtained/seen from General Branch of the Collectorate during office hours and quality of supplied must not be below the given standard /samples.
 - The samples of uniform may be obtained/seen from /Havaldar (HQ) of the Collectorate during office hours and quality of supplied must not be below the given standard /samples
 - The purchase committee can reject any bids without showing any reason as per PPRA rules 2004.
