- iii. The bidders should not have been black-listed by any authority in the past.
- iv. Bidders are required to furnish Security Deposit of 5% of their offer, in the shape of pay order or demand draft from a scheduled bank in favor of the Collector, Collectorate of Customs Appraisement (East), Customs House, Karachi. This Security Deposit shall be refunded to the unsuccessful tender participants. The Security Deposit shall be returned to the successful bidder on completion of the period of tender contract.

The price shall be offered in local currency and include all duties and taxes and V the expenses incurred on supplies including transportation, installation, labour etc, where required.

- vi. The tender bid must mention the type of warrantee and after sale services, if any.

- x. The tender bid must be valid for at least 90 days, after opening of tenders. The price offered should be inclusive of Government duties and taxes including Sales Tax, Sindh Sales Tax stamp duty @ 0.25% of total contract amount should separately be mentioned in the Financial Proposal.
- xi. The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.

- 17. Availability of Service: 24 x 7 by at least two operators round the clock.

- 18. Company will respond to call within 06 hours & emergency complaint will be attended within 04 hours or subject to traffic situation within the city.
- 19. The vendor will provide all the material and consumables required after the approval of competent authority of Collectorate of Customs Appraisement (East), Karachi.
- 20. The contractor shall provide all consumable items to be replaced as mentioned above in the table.
- 21. The contractor shall provide replacement of components for 386 KVA Diesel Genset (one time charges only). All parts and material will be new as mentioned above in the table.
- 22. Preventive Maintenance (PM) will be due at 200 Running Hours or 4 months whichever is earlier for Diesel Genset. Vendor is required to provide four (04) Preventive Maintenance services per year. However, in case of extensive utilization of any Genset, Appraisement (East) Collectorate may ask for additional services at respective location on the same terms and conditions with same charges as quoted in prescribed form of tender bid.
- 23. The Collectorate of Customs Appraisement (East), Custom House Karachi may depute its representative to supervise PM activity with the authority to check the workmanship applied and quality of material being used.
- 24. The representative will have the authority to suspend the PM activity if the quality of workmanship and material is not satisfactory.
- 25. All Engineering services will be provided free of cost except Minor / Major Engine Overhauling, F/I Pump & Injectors Calibration. Tappet Adjustment, Turbocharger Overhauling, Radiator repairing descaling.
- 26. The offer shall be valid for and up to 23.12.2021.
