4. The quotations may be submitted inclusive of all taxes alongwith detail of warranty, delivery time period after placement of order.
5. Quantity may be reduced as per availability of funds..
6. Bids shall reach in the office of the undersigned on or before **02:00 pm on 30-03-2022** which will be opened on same day at 02:30 pm in the presence of bidders or their authorized representatives.
