

- Income Tax / Withholding Tax will be deducted in accordance with the law. Kindly note that the Sales Tax (if applicable) shall also be deducted in accordance with the law.

 - Copies of Income Tax and Sales Tax registration certificates;
 - Affidavit (on legal paper) to the effect that the firm has never been black- listed by any agency of government/semi government/autonomous or business concern; and
- Bids shall reach in the office of the undersigned on or before 11:00 hours on 07-06-2022 which will be opened on same day at 12:00 hours in the presence of bidders or their authorized representatives.
