- iii. The bidders should not have been black-listed by any authority in the past.
- iv. The bidders are required to furnish security deposit of 5% which is Rs.500,000/-, in the shape of pay order or demand draft from a scheduled bank in favor of the **Collector, Collectorate of Customs (Enforcement), Customs House, Quetta**. The Security deposit shall be refunded to the unsuccessful bidder(s). The Security Deposit shall be returned to the successful bidder on completion of the tender contract.
- v. The price shall be offered in local currency and include all duties/ taxes and the expenses incurred on supplies including transportation, labor etc. where required.
- vi. The tender bid must mention the type of warrantee and after sale services, if any.

- xii. The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall, upon request, communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposal, but is not required to justify those grounds.
- xiii. The procuring agency shall announce the results of bid evaluation in the form of a report giving justification for acceptance or rejection of bids at least three days prior to the award of procurement contract. A copy of the result shall be placed on the notice board of Collectorate of Customs (Enforcement), Custom House, Quetta
