Quotations in Pak Rupees (Delivered Duty Paid basis) are invited from experienced vehicle rental agencies/ companies having valid registration/ NTN and GST Number to provide vehicle(s) on rental basis (without driver, fuel and routine maintenance) for official and operational usage for the period of One (01) Year as per the following specifications/ requirements:

### Qualifications of the Vendor/ Firm/ Company

The following vendors/ companies are eligible to participate in the tender:

1. Only firms registered with respective bodies can participate in the tender.
2. The firm shall be registered with tax authorities.
3. Never blacklisted by any Government, Public and/ or Autonomous agency/ authority.

### Documents Required

The firms eligible to apply are required to submit the following documents with their proposal:

1. Status of the Firm (i.e., Sole-proprietorship, Partnership, Limited Company) with date of establishing the business, relevant experience and no. of businesses/branches owned, along with the documentary evidence. (Attach certificates of registration and experience).
2. Registration documents with Taxation Authorities. NTN/FTN/STRN etc.
3. Professional Tax Certificate
4. An undertaking on legal paper that the company has never been blacklisted.
5. Full Address and contact numbers of the office.

### Method of Procurement

Bidding will be conducted using the **Single Stage Single Envelope** procedure specified in Public Procurement Rules, 2004 and is open to all eligible bidders as defined in those Rules and further detailed in this document that meet the minimum qualification criteria as mentioned above.

### Response Time

The sealed bids clearly marked as “1(40)/DD(F&B)/PO/2021 for Hiring of Vehicles on Rental basis” must reach the Program Office, Room No. 453, 4<sup>th</sup> Floor, FBR (HQ), Constitution Avenue, G-5, Islamabad by/ before **02:30 PM (Local Time) dated July 07, 2022.**

## **Opening of Bids**

- Bids received shall be opened on **July 07, 2022 at 03:00 PM** in the FBR House, Islamabad.
- All bids shall be opened publicly in the presence of the participating bidders or their authorized representatives.
- If bids closing/ opening date falls on local/ national/ public holiday, the date of bids closing/ opening shall be the next working day on the same time and venue.

## **Bid Price**

- Bid prices quoted shall be inclusive of all taxes and duties. Financial Bid Performa is given at Annex-II.
- The prices quoted shall be binding on the bidder(s) for a period of at least 90 days besides the Agreement validity/ period as detailed hereto in this document.

## **Terms and Conditions:**

- The Federal Board of Revenue “FBR”/ Purchaser will be responsible for routine engine oil change, repairs and maintenance of the vehicles along with driver arrangements.
- The vehicles should be comprehensively insured and in case of accident and any other legal matter, the successful bidder shall handle all the matters with insurance company.
- Purchaser will not be responsible for any loss whatsoever due to security risks, unforeseen weather or any other such scenario.
- Any federal and provincial taxes/ duties will be deducted as per directives of the Government issued from time to time.
- Rental payment will be made on monthly basis on submission of verified bill.
- The agreed monthly rent shall remain unchanged throughout the tenure of the Agreement and revision/ hike of any type whatsoever shall not be acceptable and may result in encashment of the Performance Guarantee “Earnest Money”.
- Any disfiguring/ overwriting or manipulation in the proposal shall be liable for rejection.

## **Evaluation of Bids:**

- All bids should comply with the eligibility criteria and other terms and conditions mentioned herein above.

## **Rejection of Bids:**

- Incomplete/ conditional and/ or Late Quotations (submitted after the time prescribed) shall be rejected and returned unopened.
- Failure in submission of the required documents as detailed here-above/ here-below will result in the rejection of bid/ proposal. Detailed documentary requirements are mentioned at Annex-I.
- Any bid received without earnest money/ bid security, shall be rejected.
- Purchaser reserves the right to reject all bids or proposals at any time prior to the acceptance of a bid or proposal.

## **Award of Tender:**

- Tender would be awarded to financially the lowest bidder (offering consolidated the lowest monthly rent – combining/ for all five types of vehicles, not individually) meeting all the other/ qualification requirements including submission of bid security.
- Payment will be made on monthly basis upon successful delivery of the vehicle/ services as per specifications and other requirements/ details mentioned in this document.
- Earnest money at the rate of 5% of the quoted bid (consolidated monthly rent of all 05 vehicles X 12 months) shall be submitted with the bid/ proposal in the form of bank draft/ pay order (valid/ extendable for the entire Agreement period) in favor of the Director (Program Office-PRRP), FBR.
