Terms & Conditions:

1. Tender must be accompanied by a Bank Draft/Pay Order of 2% of quoted value in favor of Chief Commissioner Large Taxpayers Office, Multan as earnest money, otherwise tender shall be rejected.
2. The bidders shall be on Active Taxpayer List (ATL) and shall be regular Sales Tax return filer. (WI applicable).
3. Bidder firm shall attach an affidavit of Rs.100/- on stamp paper (latest and Original) to the effect that the bidder has not been black listed by any of the Govt. Departments.
4. The quotations may be submitted inclusive of all taxes.
5. Income Tax / Withholding Tax will be deducted in accordance with the law. Kindly note that the Sales Tax (where applicable) shall also be deducted in accordance with the law.
6. All Proposals should include:
 - i) Company's profile, list of such projects handled, list of clients with telephone numbers and addresses;
 - ii) Copies of Income Tax and Sales Tax registration certificates;
7. Bids shall reach in the office of the undersigned on or before **11:00 hours on 27-09-2022** which will be opened same day at **12:00 hours** in the presence of bidders or their authorized representatives.
8. Bidder (s) who does not qualify cannot challenge the findings of the evaluation or ask for reason of disqualification.
10. The procuring agency reserves the right to accept or reject any or all bids/proposal in accordance with Rule 33 of PPRA Rules, 2004.
