Terms and Conditions

- i. The tender shall be granted on the basis of competitive bidding process, as is embodied in Public Procurement Rules, 2004.
- ii. The bidder should be registered with Income Tax, Sales Tax, having their own office & Phone/ fax numbers (if found contrary, the tender will be rejected).
- iii. The bidders should not have been black-listed by any authority in the past.
- iv. The bidders are required to furnish security deposit of 2% of total amount in the shape of pay order or demand draft from a scheduled bank in favor of the Collector, Collectorate of Customs Enforcement, Customs House, Quetta. The Security deposit shall be refunded to the unsuccessful bidder(s). The Security Deposit shall be returned to the successful bidder on completion of the tender contract.
- v. The price shall be offered in local currency and include all duties/ taxes and the expenses incurred on supplies including transportation, labor etc. where required up to 30-06-2024.
- vi. The tender bid must mention the type of warrantee and after sale services, if any.

- x. The tender bid must be valid for upto 30-06-2024, after opening of tenders.
- xi. Payments will be made on the basis of verification / inspection by concerned staff and subsequent report submission.
- xii. The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall, upon request, communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposal, but is not required to justify those grounds.
- xiii. The procuring agency shall announce the results of bid evaluation in the form of a report giving justification for acceptance or rejection of bids at least three days prior to the award of procurement contract.
