## **TERMS & CONDITIONS:**

- Auction shall be held strictly in accordance with the provisions of the Customs Act, 1969 and Customs Rules, 2001 notified vide SRO 450(I)/2001 dated 18-06-2001.
- All the interested parties / bidders shall abide by all the conditions under the relevant provisions
  of the Act and Rules.
- iii. Auction will be on "AS IS, WHERE IS" basis and no request for cancellation of Auction on the basis of any deficiency, if found in auctioned goods after fall of hammer, shall be accepted. However, auction of non-sea worthy empty containers (118 Nos.) at QICT shall be conditional i.e. delivery thereof would be subject to scrapping at the expense of successful bidder.
- iv. Intending bidder(s) has to present valid CNIC in original and submit copy thereof.
- v. Successful bidder has to deposit 25% of the highest bid offered as earnest money on the spot.

- vi. Earnest money can be deposited in the form of bank pay order in the name of <u>Collector of Customs</u>, <u>Appraisement- East</u>, <u>West or SAPT</u>, <u>Karachi</u>, as the case may be, for lots auctioned at Karachi and Collector of Customs, <u>Appraisement</u>, <u>PMBQ</u> for lots auctioned at Port Qasim.
- vii. In case bank officials are not present on auction site, the bidder may deposit earnest money by hand to the Customs officer in the form of bank pay order in the name of <u>Collector of Customs</u>.
- viii. Balance amount shall be deposited within seven (07) days of the display of the approved lots on the Notice Board failing which earnest money shall, subject to rules, be forfeited in favour of the Federal Government.
