  - Bids should be attached with pay order in the name of “Deputy Director NNDA of Customs, 5<sup>TH</sup> Floor Custom House , 24- Mauve Area G-9/1 Islamabad” equivalent to Rs. 50,000/- as call deposit.
  - Bids shall be opened at **14.00 hours** the same day (**10.12.2024**) in the presence of competitors.
  - Successful bidder will have to provide the uniform during the financial year 2024-25 within 15 days after the issuance of purchase orders failing which the amount of call deposit shall be forfeited and order shall stand cancelled.
  - The bidder must have his own factory/stitching unit in Rawalpindi/ Islamabad with installation of all necessary machinery and relevant experience of least two year. The facility may be visited by purchase to ensure the availability of machine and skilled staff.
  - The competent Authority reserves all rights to accept or reject any tender, if the materials used in the samples are not found as per quality agreed upon.
  - The samples of uniform of officials may be obtained/seen from General Branch of the NNDA during office hours and quality of supplied must not be below the given standard /samples.
  - The purchase committee can reject any bids without showing any reason as per PPRA rules 2004.
