Large Taxpayers Office, Multan invites bids from experienced and reputable firms having valid registration with tax and other relevant authorities, for “**Service and Maintenance of Air Conditioners**”. The firms submitting their bids must be appearing on Active Taxpayers Lists of Income Tax issued by Federal Board of Revenue, Government of Pakistan.

**Terms & Conditions:**

1. Tender must be accompanied by a Bank Draft/Pay Order of 2% of quoted value in favor of Chief Commissioner Large Taxpayers Office, Multan as earnest money, otherwise tender shall be rejected.
2. The bidders shall be on Active Taxpayer List (ATL) and shall be regular PRA return filer. (Where applicable).
3. Bidder firm shall attach an affidavit of Rs.100/- on stamp paper (latest and Original) to the effect that the firm has not been black listed by any of the Govt. Departments.
4. The quotations may be submitted inclusive of all taxes.
5. Income Tax / Withholding Tax will be deducted in accordance with the law. Kindly note that the Sales Tax (if applicable) shall also be deducted in accordance with the law.
6. All Proposals should include:
  - i) Company's profile, list of such projects handled, list of clients with telephone numbers and addresses;
  - ii) Copies of Income Tax and Sales Tax registration / PRA certificates;
7. Bids shall reach in the office of the undersigned on or before **11:00 hours on 18-03-2024** which will be opened on same day at **12:00 hours** in the presence of bidders or their authorized representatives.
8. Bidder (s) who does not qualify cannot challenge the findings of the evaluation or ask for reasons of disqualification.
