SUBJECT: INVITATION OF SEALED BID FOR PURCHASE OF SEIZED/CONFISCATED F/O DIESEL 12,580/- LITERS

Please refer to the subject cited above.

2. Sealed quotations//bids invited for auction/sale of seized/confiscated foreign origin diesel 12,580/- Liters, "**as is where is**" basis, lying at Field Intelligence Unit DI Khan (9,880/- Liters) and Peshawar (27,00 Liters).

3. As per prevalent laws, 10 % withholding tax shall be applicable on the accepted value of the auctioned High Speed Diesel 12,580/- Liters. Interested **eligible** bidders may send sealed bids quoting therein per liter price of F/o diesel exclusive of 10 % WHT as described above, with 25 % bid price in the shape of price of pay order (along with certified copy of application to bank for issuance of pay order issued by duly registered OMC/authorized government organization) in favor of the Collector, Model Customs Collectorate (Enforcement & Compliance), Peshawar on or before **24-04-2024**. The sealed bids can also be submitted by bidder's authorized representative on or before **24-04-2024** till 1300 hours after which bid will be entertained. Properly received sealed bids will be opened in front of the committee of Directorate Intelligence & Investigation (Customs) – FBR, Peshawar in the presence of representatives of bidders at 1500 hours on same day on **24-04-2024** in the office of Deputy Director Int & Inv (Customs) – FBR, Peshawar.

4. **Other terms and conditions:**

- i. **Only eligible bidders may apply with proof (copy of license and others documents) for entitlement of purchase and / or sale of the above said product.**
- ii. Bids completed in all respect and addressed to the Director, Directorate of Intelligence & Investigation (Customs)-FBR, Peshawar must be delivered by hand or through registered mail/ courier at Directorate of Intelligence & Investigation (Customs)-FBR, Peshawar on or before **24-04-2024**.
- iii. All the Oil Marketing Companies (OMC's) will be represented by their authorized employees only, carrying original CNIC and company Service Card/authority letter.
- iv. All the payments, earnest money equal to 25% of the bid offer will be made from OMC's own declared account.
- v. Late bids will not be considered / accepted.
- vi. Incomplete and conditional bids will not be entertained.
- vii. Bids of blacklisted bidders by any Government Agency / Department will not be considered.
- viii. Bidders engaged in corrupt or fraudulent practices (including collusion / pooling) will be declared ineligible whether indefinitely or for stated period of time.
- ix. The quantity of High Speed Diesel may vary due to unavoidable circumstances / leakage / environmental conditions.
- x. The competent authority reserves the right to accept or reject the bid at any time before or after the auction.
- xi. Place of delivery shall be respective Station, where the goods are lying as mentioned vide Para – 2 above
