Auction of Fresh / Leftover lots of General Cargo, Old & Used Vehicles will be held as per schedule in the premises of Directorate Intelligence & Investigation-Customs, Lahore, under Customs Rules SRO 450(1)/2001 and other (Relevant Rules) on **“AS IS WHERE IS BASIS”.NO TERMS AND CONDITIONS.** The vehicles will be sold on **“AS IS WHERE IS BASIS”** in accordance with the provision of appointment of auctioneers and auction procedure Rules SRO 450(1)/2001.

1. The bidder will have to pay 25% of the amount of the highest bid as earnest money immediately after fall of hammer, failing which the bid will be cancelled and the vehicles will be sold to the second highest bidder or the highest bidder after re-auction as deemed appropriate. And a copy of CNIC/NTN & Cell Number will have to be provided by the successful bidders on the spot.
2. The successful bidder will have to deposit 25% of the bid immediately on the fall of

hammer, which will be returned in case of rejection of the bid/sealed offer.

3. The remaining balance 75% Plus 10% Income Tax (Filer) & 20%( Non-Filer) of the approved lot will be deposited by the successful bidders within 7 working days of the approval of the bid, otherwise 25% of the earnest money will be forfeited as per auction rules.
4. The bidders can also offer the bid through sealed tender along with the Pay Order of 25% bid amount in favor of Collector of Customs ,one day before the date of auction.
5. The conditions laid down for auction can be changed by the competent authority before the commencement of auction of a particular lot to facilitate the auction goods. Collector/Director reserves the right of rejection of bid/sealed offer without assigning any reason under Rule 75 of Custom Rules SRO 450(1)/2001.
6. The name of the successful bidder will be on record and no name will be entertained who is not present in the auction.
