- i. Weight or length for an excess, however, the successful bidder shall have no claim over it and shall pay the extra amount due.
- ii. The bidder will have to pay 25% of the amount of the highest bid as earnest money immediately after fall of hammer, failing which the bid will be cancelled and the goods will be sold to the second highest bidder or the higher after of re-auctioned as deemed appropriate.
