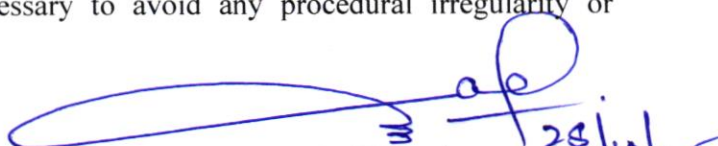
Extension in bid submission timelines through corrigendum

Discussion:

The participants discussed the matter in detail. It was informed that the subject tender was published in the daily newspapers on 17th October, 2025, after obtaining the necessary approvals. However, due to technical glitches in the PPRA ePADS system, the Standard Bidding Documents (SBD) could not be uploaded in time, resulting in a mismatch between the bid opening dates mentioned in the advertised IFB and those appearing on the online system. To rectify this and ensure compliance with PP Rules, 2004, it is essential that both dates correspond. The only feasible way to achieve this is to extend the original bid submission date by five (06) days through the issuance of a corrigendum, in accordance with the applicable PP Rules.

Decision

After detailed deliberation, the Committee unanimously decided that the extension in bid submission by (06) days till 05-11-2025 is necessary to avoid any procedural irregularity or mis-procurement.

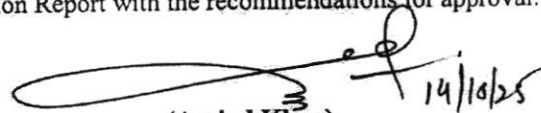
