2. The Purchase Committee (PC) has evaluated rates of consumable items repairs/installations and services of Photocopiers, Air-conditioners etc. in the light of specification mentioned in schedule "A" of Bidding Documents uploaded on (e-Pad). While evaluation of rates offered by the firms, it has been observed that the firms who stood lowest and quoted their rates for genuine toners on the basis of authorized/sole distributors of different types of Computer Printers, Photocopiers, Fax Machines etc. are comparatively high as compare to others. Rates of remaining consumable items are also seeming to some extent at par with market rates.

3. Rates of all items available on (e-Pad) which have seen by the Members Purchase Committee as well as respective vendors of subject Tender. Being the responsive bidders and their appropriate rates, Tender Purchase/Evaluation Committee recommends to procure all consumable items as per criteria devised in the Bidding Documents.


4. M/s Jamal & Brothers, Islamabad, M/s Shirazi Trading Company (Pvt) Ltd., Islamabad, have quoted the rates of their respective brands toners like HP and Canon, for which they are authorized distributors and have also produced their letter/ certificates from original manufacturer and principal suppliers.

5. Besides, M/s Marghalla Enterprises, Islamabad, M/s K.S Engineering and M/s Fazal Din & Son have quoted their rates for repairs, services/installation of AC and repairs/polishing of different types of office furniture as per schedule "A" of bidding documents and their rates are approximately similar with the market rates. Rest of the firms have quoted their rates which have also been scrutinized in accordance with schedule "A" of bidding documents and no discrepancy has been found.

6. Recommendations of Purchase Committee for selection of successful bidder/firms for supply against respective consumable items and repair of furniture/photocopiers, and installation of AC etc. may be finalized one evaluation report is announced in pursuance of Rule 35 of Public Procurement Rules, 2004 for information and expression of reservation by concerned firms, if any.

7. It is recommended that evaluation report may be announced among all bidders as required under Rule 35 of Public Procurement Rules 2004 before awarding of contracts.
