3. Interested Firms / Contractors may download tender documents online from website of PPRA and FBR or get from the address given below, during office hours till closing date.
4. The said tender will be processed through Single Stage One Envelop bidding.
5. These proposals will be opened on the same day at 02.00 pm hours in the Conference Room at the Ground Floor of Custom House, Multan in presence of the applicants.
6. The application must accompany a security amount Rs. 20,000/- each lot in the shape of Pay Order or Bank Draft in favour of Collector, Collectorate of Customs Enforcement-Indus, Multan issued by any scheduled bank of Pakistan.
7. The Applicant must clearly mention name of category / lot applying for, on envelop and in Pre-qualification Documents.
8. The services will be obtained as per availability of budget.
9. The procuring agency reserves the right to reject any or all the proposals under Rule-33 of the PPRA Rules 2004.

1. INVITATION TO BIDS

Collectorate of Customs Enforcement-Indus Multan intends to introduce the process of pre-qualification of Firms / Contractors for work at Custom House, Multan, in order to streamline its procurement procedures for following categories / services.

1. Repair of Building
2. Repair of Vehicles
3. Repair of Machinery
4. Repair of Furniture and Fixtures
5. Repair of Hardware
6. Repair of IT Equipment
7. Transportation of Goods

All reputable and well established contractors are invited to apply for the pre-qualification by submitting the pre-qualification proposal Proforma. The CoCE-Indus, Multan will process all the procurements in accordance with the policy defined and specified under PPRA Rules by the Government of Pakistan.

2. INSTRUCTION TO BIDDERS

- 2.1 The selection of Firms / Contractors will be based on Prequalification process as defined in the PPRA Rule – 16A Govt. of Pakistan. The CoCE-Indus, Multan will adopt single stage one envelope bidding procedure as laid down in Public Procurement Rules 2004 Rule # 36 (a).
- 2.2 The bid shall be a single envelope, containing prequalification proposal for a single category. The envelope shall be marked as “Prequalification Proposal for -----Category Name-----”. The CoCE-Indus, Multan engaging in prequalification is announcing, in the prequalification documents, all information required for prequalification including instructions for preparation and submission of the prequalification documents, evaluation criteria, list of documentary evidence required by Firms / Contractors to demonstrate their respective qualifications and any other information that the CoCE-Indus, Multan deems necessary for prequalification. The CoCE-Indus, Multan is providing a set of prequalification documents to Firms / Contractors.

- 2.3 The CoCE-Indus, Multan shall evaluate the proposal in a manner prescribed given in the document. During the evaluation no amendments in the prequalification proposal shall be permitted. After prequalification, only the prequalified Firms / Contractors shall be entitled to participate in the subsequent procurement proceedings. CoCE-Indus, Multan, at any stage of the procurement proceedings, having credible reasons for, or prima facie evidence of, any defect in the capacity or otherwise of a Firm / Contractor, whether or not prequalified, may require the Firm / Contractor to provide such further information concerning the professional, technical, financial, legal or managerial competence as CoCE-Indus, Multan may decide.
- 2.4 CoCE-Indus, Multan shall disqualify a Firm / Contractor on the ground that it had provided false, fabricated or materially incorrect information.
- 2.5 Only 03 Firms / Contractors will be short- listed / selected.
- 2.6 The bidders must submit **Bid Security @ of Rs.20,000/-** for each lot in shape of Pay Order, Demand Draft, Call Deposit Receipt from any scheduled Bank in favor of **the Collector, Collectorate of Customs Enforcement-Indus Multan** otherwise prequalification will be rejected.
- 2.7. Bidder(s) must attach General Sales Tax (GST) registration certificate and National Tax Number (NTN).
- 2.8 A separate agreement shall be executed with successful bidder.
- 2.9 Only those firms are allowed to participate in the tender who are General Sales Tax (GST) registered, have National Tax Number (NTN) and exists on Active Tax Payer List of FBR.
- 2.10 Bidder(s) must have sound financial position, sufficient experience, well reputation and capability for timely completion / provision of services ordered.

3. ELIGIBILITY AND PREQUALIFICATION CRITERIA

The bidders fulfilling the following eligibility criteria, will be declared eligible for Prequalification process which is provided as Annexure-B.

- i. Affidavit on stamp paper, declaring that the company is not black listed by any Govt. agency / authority (Original required)
- ii. Bidder must be Income Tax, General Sales Tax (GST) registered and on Active Taxpayer List of FBR (Copies required),
- iii. Kindly fill the **Annexure – A and Annexure - B** and attach the supporting documentary evidences as mentioned above and also in each annexure;

- iv. And also sign the declaration form at the end of document and attach with your other documents.

4. SCOPE OF JOB

- a. CoCE-Indus, Multan will offer a prequalification letter of one (01) year up to 30th June, 2026 (which is further extendable) to a qualified bidder for required services that the period of contract can be terminated by the CoCE-Indus, Multan without assigning any reason or intimation.
- b. The qualified Firms / Contractors will share the quotations of required services as and when required by CoCE-Indus, Multan.
- c. The Firms / Contractors will provide financial proposal for required services.
- d. The Firm / Contractor with lowest offered bid will be awarded work order for the said services.
- e. The Firm / Contractor will provide quality work/services to CoCE-Indus, Multan within agreed timelines of work order during the contract period.

5. TERMS OF REFERENCE

To provide quality and timely services, Firm / Contractor will agree on following terms of references:

- a) The Firm / Contractor will be bound to provide required service within agreed timelines starting from issuance of work order duly conveyed through official letter.
- b) Income tax, GST (as applicable) will be deducted in accordance with the provisions
- c) of Government Rules amended from time to time.
- d) The payment for the services will be made through cross Cheque on the successful completion of Job and receipt of valid sales tax invoice.

6. GUIDELINES

- I. Only short-listed Firms / Contractors will be considered for financial proposals / quotations. The financial proposals will be called separately from qualified bidders.
- II. All documents and information received by CoCE-Indus, Multan from Contractors will be kept confidential.
- III. Documents submitted to CoCE-Indus, Multan will not be returned.
- IV. All expenses related to participation in this prequalification document shall be borne by the bidders.
- V. Documents shall also be submitted in hard copies, as well, in a sealed envelope marked as "Pre-Qualification Proposal for '*---category name---*'". The envelope containing hard copies proposal shall be received in Custom House, LMQ Road, Multan during office hours till closing date.
- VI. CoCE-Indus, Multan reserves the right to request submission of additional information from bidders in order to clarify/further understand aspects of technical proposal, if required.
- VII. CoCE-Indus, Multan reserves the right to verify any information provided by the bidders.
