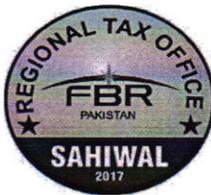

- Electronic bidding documents as per regulations, containing detailed terms and conditions, specifications and requirements etc. are available for the registered bidders on **EPADS** at [www.eprocure.gov.pk](http://www.eprocure.gov.pk)
  - Applications should be submitted electronically only through **EPADS**. Manual submission of Applications is not allowed.
  - The electronic Pre-qualification documents / proposals must be submitted by using **EPADS** on or before **03-12-2025** at **02:00 PM** which will be opened on the same day at **02:30 PM** in **Conference Room, RTO, Sahiwal** through **EPADS**. **All interested bidders must register themselves at EPADS at <http://eprocure.gov.pk>**
  - Applications, which are incomplete/not signed/not stamped/late or submitted by other than specified mode, will be rejected. The contract will be awarded to the most advantageous bid.
  - Payment will be made as per available/released budget.
  - The supplies would have to be according to specifications/samples as approved by the Purchase Committee.
  - Rate of each item/article should be quoted separately.
  - Tender must be accompanied by a Bank Draft/Pay Order of **3%** of quoted value in favour of Chief Commissioner Inland Revenue, Regional Tax Office, Sahiwal as earnest money, otherwise tender shall be rejected.
  - The bidders shall be on Active Taxpayer List (ATL) and shall be regular Sales Tax return filer. (Where applicable).
  - Bidder firm shall attach an affidavit of Rs.100/- on stamp paper (latest and original) to the effect that the firm has not been blacklisted by any of the Government Departments.
  - The quotations may be submitted inclusive of all taxes.
  - Income Tax/Withholding Tax will be deducted in accordance with the law. Kindly note that the Sales Tax (if applicable) shall also be deducted in accordance with the law.
  - All Proposals should include:
    - Company's profile, list of such projects handled, list of clients with telephone numbers and addresses;
    - Copies of Income Tax and Sales Tax registration certificates;
