Bidding will be conducted through National Competitive Procurement using a Request for Bids (RFB) as specified in the World Bank’s Procurement Regulations for IPF Borrowers July 2016 (Revised November 2017 & August 2018) (“Procurement Regulations”) and is open to all eligible Bidders as defined in the Procurement Regulations.

Interested eligible Bidders may obtain further information from Office of Additional Director (Procurement & Finance), Pakistan Raises Revenue Project, Federal Board of Revenue and inspect the procurement document during office hours 1000 to 1400 hours at the address given below.

The eligible Bidders may download the Bidding Document at **no cost** from the website www.fbr.gov.pk/tenders. Bidders opting to download the Procurement Document from the aforesaid website, shall inform the Federal Board of Revenue, in writing at the address given below failing which the Federal Board of Revenue shall not be responsible if they do not receive clarifications and amendments, if any from the Board. The document in hard/ printed form; on specific request via official email or printed over official letterhead duly signed and stamped by the authorized signatory, can be sent through courier for a non-refundable amount of Pak. Rs. 15,000 or for an equivalent amount in a freely convertible currency.

Late Bids will be rejected.** The outer Bid envelopes marked **“ORIGINAL BID”**, and the inner envelopes marked **“TECHNICAL PART”** will be publicly opened in the presence of the Bidders’ designated representatives and anyone who chooses to attend, at the address below on **17th April, 2025** immediately after the bid submission deadline. All envelopes marked **“SECOND ENVELOPE: FINANCIAL PART”** shall remain unopened and will be held in safe custody of the Federal Board of Revenue until the second public opening.

A Bid must be accompanied by a **“Bid Security” amounting of PKR 15,000,000/-**.
