November 2017 and August 2018 (“Procurement Regulations”), and is open to all eligible Bidders as defined in the Procurement Regulations.

Bidders opting to download the Procurement Document from any of the aforesaid website, shall inform the Federal Board of Revenue, in writing at the e-mail or mail address given below failing which the Federal Board of Revenue shall not be responsible if they do not receive clarifications and amendments, if any, from the Board. The bidders can request the office of undersign for documents in hard/ printed form through an official email or letter printed over official letterhead duly signed and stamped by the authorized signatory by submitting tender fee (non-refundable) in shape of Pay Order/ Demand Draft/ Call Deposit Receipt amounting to **PKR 15,000/-**.
6. Bids must be delivered to the address below on or before **11:30 AM** dated **27<sup>th</sup> March, 2025**. Electronic Bidding will not be permitted. Late Bids will be rejected. Bids will be publicly opened in the presence of the Bidders’ designated representatives and anyone who chooses to attend at the address below on i.e., **27<sup>th</sup> March, 2025** immediately after the bid submission deadline.
7. All Bids must be accompanied by a bid security in shape of “**Pay Order/ Demand Draft/ Call Deposit Receipt**” or “**Bank Guarantee**” of **PKR 550,000/-** issued by a scheduled Bank located in Pakistan, as per the details/ requirements given at the respective section(s)/ clause(s).
